- 1. If the modification is not completed as approved, said approval can be revoked and the modification will be required to be removed by the owner at the owner's expense.
- 2. Include one (1) copy of the documents listed below **WITH** your architectural request or it may not be accepted if it's incomplete.
- 3. If you are doing the work yourself, put "Homeowner" next to "Contractor Name" on the <u>Architectural Change</u> <u>Application</u>. Only submit documents 1-3 that are listed below.
- 4. I/we am responsible to pay for and repair any and all damage done to the common areas as a result of the installation.
- 5. I/we must comply with all applicable the state, county, or city building codes and that I/we must obtain all necessary permits and approvals at my expense.
- 6. I/we must abide by the decision of the Architectural Review Committee or the Board of Directors.
- 7. That if the modification is not approved or does not comply, I/we may be subject to court action by the Association and that I/we shall be responsible for all reasonable attorney's fee.
- 8. If while considering this application, the Association incurs any professional consultation expenses, such as conferring with a licensed architect, I/we will be responsible for said fee. The homeowner will be notified in advance if such services are required.
- 9. I/we understand the review process may take as long as 30 days from when the form is received by the property manager before results are determined.
- 10. I/we understand Approval from CDD (Coral Bay Community Development District) is required when it's an improvement that will occur on or affect the maintenance of easement or property owned by the District such as a fence, dock, landscape, structure, irrigation, driveway extension, etc.

I/We understand and agree to comply with the instructions provided above and will fill out, sign, and submit both pages of the Architectural Request Form to management with all other necessary documents listed below.

How to use this Palette.

The following describes the how to use the Exterior Color Palette for Indian Key.

- 1. All exterior colors must be chosen from a single color scheme within this palette.
- 2. You must choose one Body Color and one Trim Color from the choices provided.
 - "Body Color" means the color that the walls of the house will be painted.
 - "Trim Color" means the color that the soffit and other trim elements will be painted.
- 3. Each of the seven color schemes in this palette lists colors as "Body Colors" and "Trim Colors". There are two ways you can use these colors:
 - a. You can choose one of the Body Colors to paint the body of your home and one of the Trim Colors to paint the trim on your home.

For example: From Scheme 1 (Pastel Yellow), you could choose to paint the body of your home Chamomile SW 6399 and the trim Alabaster SW 7008.

b. You can choose one of the Trim Colors to paint the body of your home and then choose of the Body Colors to pain the trim on your home.

For example: From Scheme 1 (Pastel Yellow), you could choose to paint the body of your home Snowbound SW 7004 (this color is listed as one of the Trim Colors) and the trim Convivial Yellow SW6393 (this color is listed as one of the Body Colors).

Either of these combinations is acceptable.

4. The color schemes list Sherman Williams paint colors and their corresponding ID codes.

Indian Key uses the standard mailbox that's available at Home Depot, Lowe's or many other places. The attributes are:

- The mailbox is white.
- The dimensions are approximately 20"L X 9"H X 7"W
- The box is rounded at the top

The following image illustrates these general characteristics:



What's important here are the size, the shape, and the. This is meant to serve as a general example only.

The general guidelines for the post are:

- It be painted white in color.
- The post has the general form shown in the following picture.
- The dimensions of the material should be approximately 4" X 4" (round, or turned posts are not acceptable.)
- The post should be installed plumb and level so that the mailbox is at a USPS approved height.
- The post should be clean and in good repair.

The following image illustrates an unpainted post that otherwise has the correct characteristics:



Again what is important here is the general shape and characteristics. The dog-eared ends and the inset detailing are not required. This post would have to be painted white after installation to meet Indian Key standards. Such posts, or acceptable variations, are available at Home Depot, Lowe's, or many other places.

The post must be installed so that the mailbox sits at a height acceptable to the United States Postal Service.

The property address should be displayed on the post in numbers of contrasting color that are acceptable to the United States Postal Service.
